

UK asset classes size in £ trillion



REAL ESTATE OUT-PERFORMING OVER 1,3 & 5 YEARS




Long term outperformance by UK residential






Risk reward by asset class






Performance breakdown






Residential income vs other asset classes






Stable income and rental affordability


